



How to become a Com4 licensee

What is Com4 and how is it used?

Com4 is a worldwide registered Rieter trademark for yarns spun on Rieter machines. The yarns fulfill the most challenging requirements. Outstanding properties and constant high quality safeguard the competitive edge in a demanding market.





What are the advantages for a Com4 licensee?

If you want to distinguish yourself from the crowd, then use the trademark Com4. Rieter will actively support you with the marketing of your Com4 yarn by:

- presence at textile trade fairs with its own informative Com4 booth
- publishing of sources of supply for the Com4 yarns on the Rieter website
- worldwide communication at Rieter symposia
- presence in the trade press with articles and advertisements
- information on the internet
- helpful marketing documentation for your own use, such as yarn brochures, fabric samples, stickers, posters etc.

Is it possible to license fabrics?

Yes, products (i.e. knitted or woven fabrics and garments) consisting of more than 50% of the licensed yarn can be marked with the corresponding yarn brand.

What is the validation of a license contract?

The license contract is valid for 3 years.

How can someone participate in the Com4 licensing system?

Either contact the responsible Rieter sales person or apply on the Rieter website www.rieter.com via contact form. A Rieter professional core team will decide on a possible participation.

Which yarn brands can be applied for and what are the preconditions?

Yarn brands	Precondition
Com4ring	yarn produced on Rieter ring spinning machines
Com4compact	yarn produced on Rieter compact-spinning machines or on Rieter ring spinning machines with the Rieter compacting devices
Com4rotor	yarn produced on Rieter rotor spinning machines
Com4jet	yarn produced on Rieter air-jet spinning machines
Com4recycling-ring	recycled yarn produced on Rieter card, draw frame and ring spinning machine, Global Recycled Standard (GRS) certification required
	recycled yarn produced on Rieter card, draw frame and compact-spinning machine or ring spinning machine with the Rieter compacting devicesm, Global Recycled Standard (GRS) certification required
Com4recycling-rotor	recycled yarn produced on Rieter card, draw frame and rotor spinning machine, Global Recycled Standard (GRS) certification required
